
Content Priorities

Conference workshops should focus on transferable skills or "hands-on" content that can be applied immediately in out-of-school-time programs or present "best practices" and other exemplary components of these programs. Presenters are encouraged to share specific strategies that work well with diverse populations and in various afterschool and youth development settings.

Workshop Guidelines and Criteria

Please read this section thoroughly before submitting a proposal.

Workshop Guidelines:

- · Sessions are intended to be professional development opportunities with learning outcomes and should not be conducted like a sales presentation.
- · All workshops are 1 hour and 15 minutes long and run concurrently with other sessions.
- · Seating will combine classroom-style (tables with chairs) and theater-style (chairs only) unless otherwise requested.
- · Handouts are encouraged, and presenters should provide a minimum of 50 copies.
- · We reserve the right to request modifications to proposed workshops.

Selection Criteria:

- · Potential to attract, engage and stimulate new and returning participants.
- · Content appeals to direct care staff, classroom teachers, and/or administrative professionals in public school, faith-based, and community-based programs.
- · Clarity of content, presentation techniques, and learning objectives.
- · Relevance and appeal to a culturally, geographically, racially, and ethnically diverse audience.
- · Lively and interactive format that will facilitate interaction among participants.
- · Presenters' experience and qualifications.

Audio Visual Needs:

We will provide a screen and LCD projector in each presentation room. We will NOT provide laptops or any other audio-visual equipment. If needed, these items are the responsibility of the presenter. Most AV equipment can be rented from the hotel at the presenter's expense. Please identify the equipment you will be using for your presentation on your application, so we can make hotel staff aware of the possible need for technical assistance. Wi-Fi for workshop presentation will be available in the session room during the session time, compliments of FASA.

- Representatives of businesses, corporations, and consulting groups who seek to present as a part of their marketing strategies to increase business sales and who have an expectation of benefit in terms of sale of products, engagement as a consultant, or other commercial activities. Individuals fitting this description should use the Presenter Packet and Application to submit a Workshop Proposal as well as the Exhibitor Packet and Application.

Conference Registration

Please read this section thoroughly before submitting a proposal.

Primary Presenter (1) and all Co-Presenters (no limit) have two registration options:

- · Presenter FULL CONFERENCE ACCESS The presenter receives admittance to all conference events for a discounted fee of \$250. This fee covers the cost of all food and beverage events, including social events.
- · Presenter WORKSHOP PRESENTATION ONLY The presenter is on-site only to make their presentation. The presenter is not permitted admittance to any other activities of the conference. There is no fee associated with this option.
- · Co-Presenter FULL CONFERENCE ACCESS Co-Presenters pay the regular conference fee of \$375.00. This fee covers the cost of all food and beverage events, including social events.
- · Co-Presenter WORKSHOP PRESENTATION ONLY Co-Presenters are on-site only to make their presentation. Co-Presenters are not permitted admittance to any other activities of the conference. There is no fee associated with this option.
- · Exhibitors/Vendors may submit a workshop proposal. The fee for each exhibitor/vendor workshop session is \$275.00. If you are also serving as an Exhibitor, the \$275.00 fee is made in addition to the Exhibitor Fee. This fee does not grant the vendor full conference access.

Travel/Hotel:

Presenters are responsible for their travel arrangements and expenses. We will reserve a block of rooms for the conference at a discounted rate of \$135/night. Hotel information can be accessed on the conference website.
